New "Cutting Edge" Sniper Rifles on the Way

New "cutting edge, multi-calibre, bolt-action" sniper rifles are on their way to the Canadian Army, according to an announcement made by Anita Anand, Minister of National Defence, on June 10, 2022. According to the announcement, the Army will receive 229 new sniper rifles. "Making sure that the Canadian

Armed Forces are properly equipped is always a top priority. Through the Sniper System project,

we are procuring cutting edge gear for the Canadian Army and ensuring that their members are well resourced. The delivery of the new C21 sniper rifles is the last major piece of this project aimed at modernizing our sniper teams and adding to the effectiveness and readiness of the Canadian Armed Forces," said Anand. The contract to procure the rifles was awarded to Stoeger Canada and will include associated accessories such as suppressors and cleaning/maintenance kits. The contract is worth \$2.6 million and is part of a larger contract to deliver new weapon systems.

The new sniper has several improved features, including:

- New sniper magazine will hold between 8 and 10 rounds depending on calibre and include both regular and armor-piercing rounds.
- Has a proven effective range of 1200 metres and is very capable beyond that distance.
- Multi-calibre (7.62x51mm and .338 Lapua Magnum),
- Lighter, with a 60 per cent longer barrel life,
- Adjustable, with a folding stock to make it easier to transport and to accommodate various user types,
- Adaptable for in-line night vision devices to increase operational effectiveness,
- Fully interchangeable with a design that allows whole fleet management and faster/easier repairs with simple part replacement.

According to a Department of National Defence (DND) press release, sniper rifles "provide accurate direct fire on targets beyond the capacities of most small arms such as the C7 rifle." The rifle will replace the current C14 and C3A1 sniper rifles and provide Canadian Army snipers with a next-generation weapon with a proven effective range of 1200 metres. DND claims the new rifles should be delivered by the end of this year. "These new weapons are part of a wider project to equip sniper teams with new clothing, equipment, and weapons to improve our soldiers' ability to operate effectively in various environments and under a range of conditions," reads the press release. "The Government of Canada is committed to modernizing the Canadian Armed Forces so that our members have the tools they need to serve our country. This sniper rifle procurement is an example of how we are meeting the needs of the Canadian Armed Forces while ensuring the best value for Canadians," said Filomena Tassi, minister of public services and procurement.

'Obsolete' NATO Force Presence in Baltics Needs Upgrade

Estonian Defense Leader says. "It's a joke" that Russia would be deterred by a battalion.

NATO must station more forces in the Baltic nations to provide a more credible deterrent after Russia's invasion of Ukraine, the Estonian defense secretary said Wednesday. Kusti Salm, the permanent secretary of the Estonian Ministry of Defense, said the number of NATO troops in Estonia, Lithuania, Latvia today, which is intended to act as a "tripwire" for Russian aggression, is too small to deter Russian aggression or quickly push back troops from Moscow. In the time it would take for a large enough NATO force to respond, Russia would have already destroyed cities and killed civilians, leaving the alliance with the tougher task of liberating land rather than defending it in the first place, Salm said. "The current NATO strategy of tripwire defense or

deterrence by punishment...is clearly politically obsolete," he said at a Center for Strategic and Budgetary Assessments event to roll out a report on Baltic security. "We need to shift from tripwire...to deterrence by denial."

In 2016, after Russia annexed Crimea, NATO agreed to send rotational battlegroups to Estonia, Latvia, Lithuania, and Poland. When Moscow further invaded Ukraine in February, the alliance established four new battlegroups in Bulgaria, Hungary, Romania, and Slovakia. More than 40,000 NATO troops are on the eastern front of the alliance to deter encroachment from Russia. In a June 2 report, CSBA analysts argue that NATO should double the troop presence in the Baltics and ensure at least one tank battalion is in each Baltic nation. But Salm said that's still not enough. "It would be ridiculous to claim that the second largest nuclear nation in the world would somehow be deterred by a battalion. It's a joke," he said. Eastern Europeans have long called for a larger troop presence to fend off growing threats from Russia. In 2018, Poland offered to name one of its military bases after President Donald Trump to get thousands more American troops permanently stationed in the country. In August, Lithuania unveiled a brand-new 7-million-euro base just 10 miles from the Belarussian border to try to get Washington to make its rotational deployment permanent.

The Pentagon released its force posture review in November, which made modest changes in Europe, but prioritized troop presence in the Indo-Pacific. Leaders from NATO members will meet in Madrid in two weeks to set the alliance's priorities for the next decade, and what the force posture in Eastern Europe should be is expected to be an important topic of discussion. The CSBA report also made several other recommendations for NATO, as well as specific suggestions for Estonia and the other Baltic countries. NATO should "clarify and strengthen" the command structure in the Baltics, including establishing an operational headquarters in the region. The alliance should also preposition stocks of munitions like Javelins and Stingers in the region, increase NATO air and missile defense capabilities in the Baltics, and share more intelligence with allies like Lithuania, Estonia, and Latvia. The report recommended that Estonia build and expand training facilities to offer unique opportunities to encourage more NATO troops to rotate through the country. It also recommended that all Baltic nations increase defense spending to at least 3 percent of GDP, up from a target of 2.5 percent set by the countries, and to work with each other on an integrated regional defense plan.

Largest Army-Led Exercise Conducted

The largest army-led joint force-on-force exercise of the year was held to test the skills of members of the Canadian Army and their ability to integrate joint capabilities with

Exercise MAPLE RESOLVE 22, took place from May 10 – May 22, saw approximately 1,800 members of 2 Canadian Mechanized Brigade Group (2 CMBG), 680 US Army, US Army Reserve, and National Guard soldiers,

and 20 US Marines come together for this multinational exercise. Other participants also include 150 members from the British Army and other enablers from the Canadian Army and Royal Canadian Air Force, for a total force of more than 3,200 personnel. "We live in an increasingly dangerous and unpredictable world. As events in Ukraine have shown us, the ability to integrate combined arms remains fundamental to success in battle. Collective training events such as Exercise MAPLE RESOLVE 22 provide the foundational skills necessary to address current and emerging security challenges, and are thus vital to our readiness," said Gen Wayne Eyre, Chief

Airline Baggage Allowances for Military Personnel and Veterans

If you're planning your first getaway after the COVID-19 pandemic this summer, you may be wondering what your fare will look like with prices on everyday items climbing all around us. The good news is that Canada's major airlines are still waiving baggage fees for active and retired military

personnel. Airlines including Air Canada, WestJet, and even Porter are all offering discounts for military baggage. Here's what you can expect when flying on your summer getaway.

Air Canada - According to AirCanada.com, Canadian and US military members benefit from enhanced baggage allowance when they are travelling on any flight operated by Air Canada, Air Canada Rouge, or Air Canada Express. According to the website, "Eligible active and retired members of the Canadian and US military are entitled to up to three pieces of checked baggage, each weighing up to 32 kg (70 lb) each." When checking in, military members are asked to indicate they are travelling without baggage and then have their fees waived at the airport with the help of an agent. Military members have to present their military identification for the allowance. The allowance does not apply to military members who are travelling on connecting flights with other airlines. See website for details.

WestJet - WestJet also offers military baggage allowance for active and veteran Canadian military personnel for personal or business reasons. Canadian Armed Forces (CAF) members are allowed to travel with up to four bags, only three on WestJet Encore flights. They also do not charge overweight/and or oversized bag fees. However, "baggage exceeding our maximum permitted size or weight will not be accepted as guest baggage and must be shipped via cargo (all applicable fees apply)." Military identification has to be presented to be eligible for the

allowance. Fees are only waived for flights where WestJet is the operator for the entire journey. See website for details.

Porter - Like other major Canadian airlines, Porter also offers baggage allowance. Canadian and US military personnel are eligible for an enhanced baggage allowance. Baggage fees will be waived for up to three pieces of checked baggage per person, as long as the following conditions are met:

- No single piece can exceed 203 cm (80 in) in total dimensions or weigh more than 32 kg (70 lb).
- o Military identification must be shown at the airport check-in.
- o Military personnel may be active or retired.
- o Military personnel may be travelling for business or personal reasons.

Similar to Air Canada, military personnel can have the fee waived once at the airport through the help of a Porter agent. However, Porter specifically notes that the waived fees are not applicable to family or friends traveling on the same reservation. See website for details.

Flair Airlines - Canada's newest discount airline does not have any specific baggage allowance for military members. However, it does offer overall fare discounts. Military members can apply for 25 per cent off base fares through the CF appreciation website. See website for details.

Swoop Airlines - Another Canadian "ultra-low" cost airline, Swoop, also offers exemptions for military baggage. According to Swoop's website, any active or veteran Canadian military personnel are entitled to two checked bags free and one carry-on bag free. Military members or veterans can claim their free bags by getting assistance at the airport and using their military ID. Overweight and oversize fees still apply. Exemptions may be made for those being deployed. The offer does not extend to family members or others traveling on the same itinerary. A complete list of accepted IDs is on the Swoop website.

Who (or What) Is It?

Last Week: The Vickers Type 161 was an unusual 1930s pusher biplane interceptor, designed



to attack aircraft from below with a single upward-angle large calibre gun. The aircraft flew well but the concept was abandoned and only one was built. The it was designed in response to Air Ministry specification F.29/27. This called for an interceptor fighter operating as a stable gun platform for the COW 37mm gun produced by the Coventry Ordnance Works (COW) that fired 23oz (0.65 kg) shells. The pilot and gun were housed in a metal monocoque nacelle

mounted to the underside of the upper wing, leaving a gap below. The pilot's cockpit was offset to port with the gun to his right, its breech accessible. The gun was to be mounted at 45 degrees or more above the horizontal, so that the aircraft could fly below the target bomber or airship, and fire upwards into it. During World War II the Luftwaffe used a rather similar approach, named *Schräge Musik*. The specification also called for a top speed well in excess of a typical bomber's cruising speed and a good rate of climb.



What is the Canadian Defence Community Banking (CDCB) Program?

Who is eligible for the CDCB Program?

Program benefits are exclusive to regular force personnel, reserves, recruits, military families, Veterans and retirees, as well as Department of National Defence (DND) and Staff of the Non-Public Funds civilian personnel, the RCMP and the Canadian Coast Guard.

Can BMO help me if I am relocated or deployed?
