Canada's Military Will Overhaul Its Recruitment Process

In her discussions with Canadian Forces personnel, MGen Lise Bourgon noted that top-notch military instructors were critical to improving retention and culture.

The Canadian military will overhaul its recruitment process to try to speed up and streamline the procedures to bring new blood into the ranks. MGen Lise Bourgon, head of the military personnel

branch, fielded questions in mid-July from Canadian Forces members, including concerns that decades ago the recruitment process took only a few months, but now it takes years. Bourgon said changes were coming, including using more private contractors to handle some tasks in recruitment. "We have just stood up a Recruitment Modernization Team that will look at a complete re-design of our recruitment process," she said. "They will also look at contracting activities that don't need military personnel to complete (screening/medical etc.)." A transcript of the internal conversations was provided to this newspaper by military personnel concerned about the need for reform in the Canadian Forces, which is facing a recruitment crisis. No timeline was provided on how long it would take to redesign the recruitment process.

Bourgon's initiative is the result of a directive issued in late June by Chief of the Defence Staff Gen Wayne Eyre and National Defence deputy minister Bill Matthews. That 49-page document outlined a plan to prepare the military for the future as well as "overcome deficiencies that are hampering the composition and readiness of the Canadian Armed Forces." That directive, leaked to this newspaper, noted the need for reconstitution of the armed forces because of ongoing problems the military has had attracting new recruits and retaining skilled personnel. The COVID-19 pandemic has significantly reduced recruiting and the failure of military leaders to take care of their personnel has led to retention problems. The sexual misconduct crisis that has engulfed the Canadian Forces has also harmed retention and recruitment, according to the directive.

The directive from Eyre and Matthews noted there had been a "significant loss of experience and expertise within the CAF, creating a requirement to recover and rebuild the organization." It also stated the military had to "reduce staffing processes and cease activities and tasks that do not directly contribute to the growth of the CAF, operations and modernization." In her discussions with Canadian Forces personnel, Bourgon noted that top-notch military instructors were critical to improving retention and culture. "Instructors are the most important people in our Reconstitution effort and our culture change initiative; therefore, we have to be careful on who we pick and to ensure that we have the right person," she explained in the online discussion. "When we talk about retention and people leaving because they went through a bad experience, a lot of cases are linked to training events."

Some of the directive from Eyre and Matthews focused on the need to improve life for military personnel. Changes are needed to moving and housing policies to enhance retention, the document noted. Personnel policies also have to be modernized to improve quality of life,

which, in turn, will help retain skilled military staff, the directive noted. The directive for "CAF (Canadian Armed Forces) Reconstitution" was sent out to senior leaders. Eyre and Matthews noted the "directive will set in motion a significant body of work that will provide direction on the course corrections" that are needed. "Assess what capabilities and projects can be divested, paused, or re-scoped to generate capacity savings," Eyre and Matthews told the leaders. "Assess what tasks/capabilities must be retained by Defence and can be transferred from CAF to DND employee or contractor responsibility." Getting rid of old capabilities will free up staff and resources to concentrate on bringing in new capabilities. A review of capabilities will allow the military to "reduce/divest capabilities that are nearing end of life and invest in new capabilities that will be coming online," the document noted.

Among the Walking Wounded: Soldiers, Survival and PTSD


As a child, I would write up my own stories and illustrations and bind them with stiff cardboard and glue for my friends to read. I enrolled in the Canadian Armed Forces right out of high school at Royal Roads Military College near Victoria, BC. in 1983. My writing became a constant companion as I made my way forward in an Army career that spanned 34 years and numerous moves for my wife and our family. I served three overseas tours

during the full-time component of my career. The last of these tours was as a logistics battalion commander in Kandahar in 2006. For the first time since Korea, we were returning to sustained combat activity and the logistics task at hand was considerable.

My unit was less than 300 men and women charged with keeping an infantry battle group bombed up (had ample ammunition) inside of 225,000 square kilometres of battle space. This would have been a tall order on a more linear, Second World War-style battlefield with a clear front and a well-defined combat zone. In the non-linear, counter-insurgency style of warfare in Kandahar, where one could be attacked anywhere, where there was no true frontline, this made the work of my soldiers spiritually challenging. Afghanistan and that desperate summer of 2006 left a lot of my soldiers wounded and charred black on the inside. In the fullness of time, I came to realize

that I, too, was different

My latest book, Among the Walking Wounded: Soldiers, Survival and PTSD is not a military book – at least not in the traditional sense. There is certainly some grounding in the recent Afghanistan War and that worst of the Taliban Summers of 2006, but this is essential for the context of the inner story of PTSD. Among the



Walking Wounded was written first and foremost to reach soldiers who are still trapped in a psychological "no man's land" and provide them with a map to come home. Spending so much time with wounded soldiers in the aftermath of 2006, I wanted to help even in a small way with their recovery. Additionally, the book is written for the average Canadian, to offer them an inside glimpse of what PTSD is like for our soldiers, and potentially their own loved one. PTSD grafts so seamlessly with one's personality and with one's sense of self that it is almost impossible to detect unassisted. What you learn to live with eventually becomes your life and this is far from necessary now. There are many tools and supports available if one can find the strength for that initial conversation, that initial step. This book gives an account not only of my own journey but also those of two Afghanistan veterans with PTSD. One of the soldiers made it, and the other unfortunately did not. In sharing the account, I am hoping that a bright light is directed onto this shadowy action. We need to become connoisseurs where wounds to the mind are concerned.

Information must be provided at the speed of relevance in order to overcome adversaries. Increasingly, soldiers are facing skill decay and cognitive overload due to the speed and detail necessary for each decision. Joint task force commanders operating within the all-domain environment need real-time decision support to gain the advantage. Lockheed Martin Canada's Maintenance training has modernized to include two variants: VISTATM (Visual Interactive Simulation Training Application) simulations are digital twins – high fidelity, free-play graphical and behavioural models of devices, equipment, subsystems, and systems. sustainment provides assurance of an enduring capability. Continuous military operations will be achieved through better, more agile support to the dispersed land, sea and air environments and can be assured by implementing enhanced logistics Command and Control and AI-based platform prognostics. Data has the power to reduce risk in operation and deployments by enabling predictive maintenance to reduce platform downtime. The aim should be to achieve a high velocity supply chain with parts provided when and where they are needed with no single point of failure across the logistics chain. This requires a paradigm shift in platform and equipment availability and the development of superior, assured, environmentally sustainable and cost-effective logistic services. To guarantee future success, the future well-trained military force must be sustained.

Who (or What) Is It?

Last Week: SM U-14 or U-XIV was a U-boat of the Austro-Hungarian Navy during World War



I. She was launched in 1912 as the French *Brumaire*-class submarine *Curie* (**Q 87**) but captured and rebuilt for service in the

Austro-Hungarian Navy. At war's end, the submarine was returned to France and restored to her former name. *Curie* was launched in July 1912 at Toulon and completed in 1914. She measured just under 171 feet (52 m) long and displaced nearly 400 metric tons (390 long tons) on the surface and just over 550 metric tons (540 long tons) when submerged. At the outbreak of World War I in August 1914, *Curie* was assigned to duty in the Mediterranean. In mid-December, *Curie*'s commander conceived a plan to infiltrate the Austro-Hungarian Navy's main base at Pola, but during the 20 December attempt, the vessel became ensnared in harbor defenses. Two Austro-Hungarian ships sank *Curie*, killing three of her crew; the remainder were taken prisoner.

The Austro-Hungarian Navy, which had a small and largely obsolete U-boat fleet, immediately began salvage efforts and succeeded in raising the lightly damaged submarine in early February 1915. After a refit, the boat was commissioned as SM *U-14* in June but had little success early in her career. When her commander fell ill in October, he was replaced by Georg Ludwig von Trapp (Yes, the *Sound of Music* Count). *U-14* was damaged by a depth charge attack in February 1916 and underwent an extensive modernization through November. Resuming duty under von Trapp, *U-14* sank her first ship in April 1917, but had her most successful patrol in August, when she sank five ships—including *Milazzo*, reportedly the largest cargo ship in the world—in a six-day span. In January 1918, von Trapp was replaced as commander, but neither of his two successors were able to match his accomplishments. In all, *U-14* sank 11 ships with a combined gross register tonnage of nearly 48,000 tons. Returned to France at the end of the war, she rejoined the French Navy in July 1919 under her former name of *Curie*. She was struck off in 1928 and scrapped in 1929. The Battle of the Boyne connection is that the original French skipper, Gabriel O'Byrne, who was descended from Wild Geese. John's connection to the story is that his Wild Geese relative was Chevalier Gabriel Redmond.

This Week: The study of military history in Canada has had its ups and downs. Interestingly, while popular interest in history through TV, the www, and social media is high, with many publications available in print and online (your author favours BBC History Magazine, and the accompanying podcasts put out as HistoryExtra), academic interest is minimal, with very few universities offering anything remotely related to the topic. Indeed, Wilfrid Laurier University even changed the name of their Laurier Centre for Military, Strategic, and Disarmament Studies to the Laurier Centre for the Study of Canada, dropping the term military, although not the study. As a result, those with an interest in the topic have to rely on sifting through various resources



and publications, ranging from the lightweight (e.g. "Ten Things You Didn't Know about Canada's Army" seen, but not read, on a Facebook post), to the obscure ("The Short and Insignificant History of the 8th Stationary/Mobile Bath Unit"......which I just made up).

However, there is gold in them that hills, and just recently I came across a very well-researched and well-written book about a subject both topical and obscure. Reference was made to a military unit that is often either not mentioned at all, or, at best, referred to obliquely or in passing. Sadly, this otherwise excellent tome did not illustrate that unit. So, using Mr Google, we were able to find a very good image from the University of Oregon, which we present to you below.




